OBJECTIVE

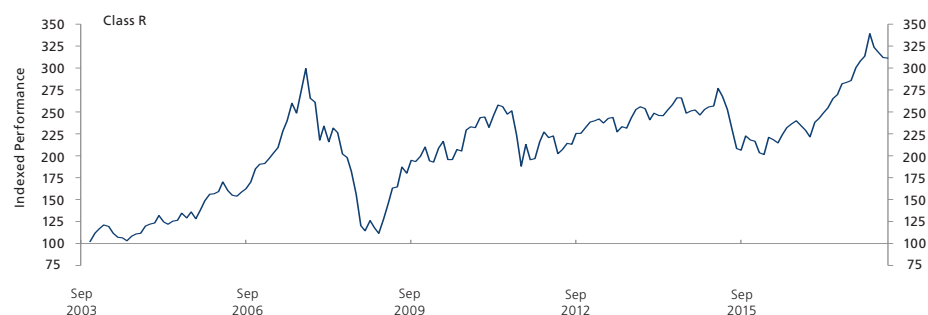
