OBJECTIVE

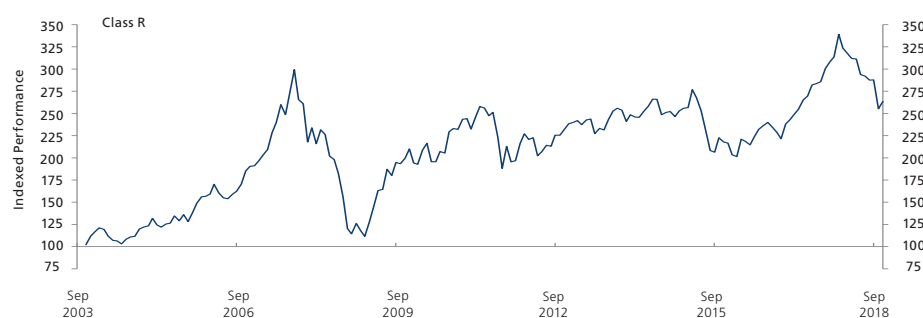

- A portfolio which is well-diversified across different countries and sectors in the Asia Pacific ex-Japan region
