

# BEA Union Investment Global Flexi Allocation Fund

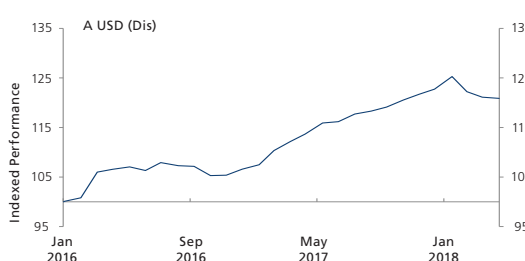
