

Important note:

Market Review and OutlookReview of Interest Rate Market

- The U.S. Federal Reserve reinforced a more dovish stance at a meeting of the Federal Open Market Committee in December 2018 and lowered the rate hike expectation for 2019. U.S. Treasury yields dropped as a result.

Asian High Yield Bonds

- Chinese high yield property bonds continue to outperform as yields tightened for the B and BB-rated names. Chinese industrial bond yields rose further due to headline news and concerns about refinancing.
- Indonesian industrial bond yields widened slightly and continued their gradual rise in the past two months. Indonesian high yield property bonds have largely remained flat. Indian bond yields widened, mainly due to a correction of the previous very tight valuation.

Market Outlook

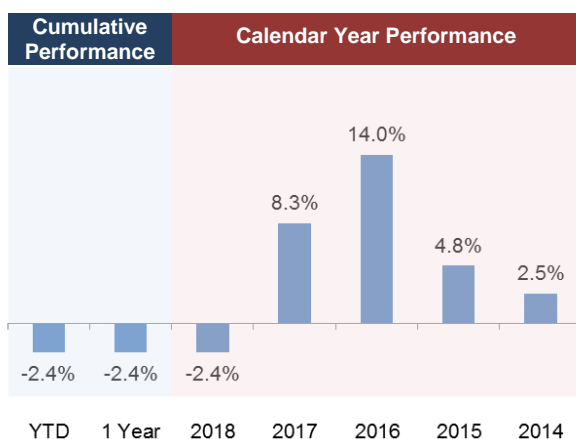
- We see attractive valuations across some higher-quality names after the market correction of the past few months. We are cautiously optimistic about emerging market currencies as a result of the lower rate hike expectations in the U.S. However, the course of trade talks between China and the U.S. is still a risk factor that may create market volatility. We still see a higher risk in privately-owned Chinese industrial names which have relatively tight onshore funding.

Investment Strategy

- The Fund continues to add exposure in Indonesian quasi-sovereign bonds in response to attractive valuations and the country's improved macro condition. We also added some positions in corporate perpetual bonds with decent carry.
- The Fund has been picking up bonds in the primary market, as we are seeing attractive new issue premiums in both the Asian investment grade and Asian high yield segments.
- We are looking for opportunities to add to its position in Asian local currency bonds.
