

Fund Special Report

Important note:

- 1. BEA Union Investment Asia Pacific Flexi Allocation Fund (the "Fund") seeks to achieve long-term capital growth and income by investing in equity securities or debt securities that are either traded in the Asia Pacific region or issued by companies incorporated in the Asia Pacific region or companies which have significant operations in or derive significant portion of revenue from the Asia Pacific region.

Chinese Property Stocks Outperform



Highlights:

- 1. Chinese property stocks outperform due to policy easing
- 2. The Fund increases its overweight position in Singaporean and Indonesian equities
- 3. The Fund looks to selectively add some higher beta Asian bonds

Fund Features

- > The Fund is an Asia Pacific equity-biased mixed-asset income fund, which invests in a prudent selection of blue-chip stocks with stable earnings and dividend growth potential.
- > The Fund captures Asia Pacific blue chips' appreciation potential using a strategy of lower volatility, it employs flexible allocation in Asia Pacific bonds to enhance returns and diversify portfolio risks.

Market Review and Outlook

Equities

- China's onshore and offshore equity markets retreated in December, mainly due to external volatility and uncertainty over trade tensions. Economic activities in China continue to slow down, while property sector outperformed due to more signals on policy easing.
- In December, Australian equities turned negative along with other markets in the region. The weakness in the stock market was broad-based due to the depreciation of the Australian dollar against the U.S. dollar in addition to the oil price correction.





- Korean equities declined in December and underperformed other markets in the region. The Korean market was dragged down by its IT sector due to weakening demand for semiconductors and the fact that the memory industry is entering a down-turn.

Bonds

- Chinese investment grade bonds underperformed mainly dragged down by market concerns over the U.S.-China trade war and sanctions on Chinese technology companies.
- Indonesian industrial bond yields widened slightly and continued their gradual rise in the past two months. Indonesian high yield property bonds have largely remained flat.

Investment Strategy

Equities

- The Fund remains cautious and strategically defensive due to continued volatility in equities. We have added defensive names with attractive valuations in the materials, healthcare, and consumer discretionary sectors.
- The Fund increased its overweight positions in the banking and industrial sectors of Singapore and Indonesia. Indonesia's investment outlook has improved in light of the recovery of the rupiah, lower rate hike expectations, and positive earnings expectations.

Bonds

- The Fund's bond portfolio duration was lengthened in December. We are looking to selectively add some higher beta names in Asia and to reduce our holdings of floaters.
- The Fund is tactically participating in investment grade and high yield new issues with capital appreciation potential.
