

Fund Monthly Report

Important note:

- BEA Union Investment China Gateway Fund (the "Fund") seeks medium to long term capital growth and income through investing primarily in equity securities and/or debt securities, that are either (a) traded in China or (b) issued by entities incorporated in China or entities which have significant operations in or assets in, or derive significant portion of revenue or profits from China.
- 2. The Fund's investments are concentrated in China's equity securities and debt securities. This may result in greater volatility than a fund having a more diverse portfolio of investments. The Fund may also be subject to withholding and other taxes imposed in China.
- 3. The Fund may invest in below investment grade, or rated BB+ or below by a China credit rating agency, or non-rated debt securities, which are subject to greater interest rate, credit and liquidity risks, higher volatility and greater risk of loss of principal and interest than higher-rated debt securities.

Infrastructure-related Stocks Outperform due to Mainland Stimulus Package



Highlights:

- 1. Chinese equities trade in narrow range amid mixed market news
- 2. Materials and industrial sectors outperformed due to stimulus package from China's State Council

Market Review and Outlook

Equities

- Chinese equities traded in a narrow range in July due to mixed news in the market. U.S.-China trade tensions escalated after the U.S. government announced another US\$200 billion tariff plan. On the other hand, the stimulus package from China's State Council's provided market support, causing infrastructure-related sectors such as, materials and industrials to outperform.
- Sector rotation continued in July, with utilities and telecommunications outperforming due to their defensive nature, while healthcare and consumer staples underperformed. China's real estate continued to remain underperform as a result of the government's on-going deleveraging policy.



<u>Bonds</u>

- Chinese high yield bond markets experienced a degree of recovery in July, due to improving investor sentiment, and supportive policy measures.
- Sentiment regarding Chinese high yield industrial bonds was supported by window guidance from the People's Bank of China (PBOC) and its partial relaxation of rules on wealth management products and asset management.

Investment Strategy

Equities

- The Fund added Chinese industrial stocks as we believe negative factors have been fully factored in.
- The Fund increased its exposure in utility stocks in order to reduce market beta during any market correction.
- We remain positive about the outlook for consumer-related sectors, as China is seeing an upgrade in consumption patterns as a result of greater access to personal credit.

Bonds

- In view of market sentiment having improved in July, the Fund switched some of its investment grade bond exposure into selective high yield bonds with solid financial profiles.
- Despite adding exposures in high yield bonds, the Fund's bond selection remains skewed toward more defensive shortdated bonds and issuers with better credit quality.
