

Fund Monthly Report

Important note:

- BEA Union Investment China Gateway Fund (the "Fund") seeks medium to long term capital growth and income through investing primarily in equity securities and/or debt securities, that are either (a) traded in China or (b) issued by entities incorporated in China or entities which have significant operations in or assets in, or derive significant portion of revenue or profits from China.
- 2. The Fund's investments are concentrated in China's equity securities and debt securities. This may result in greater volatility than a fund having a more diverse portfolio of investments. The Fund may also be subject to withholding and other taxes imposed in China.
- 3. The Fund may invest in below investment grade, or rated BB+ or below by a China credit rating agency, or non-rated debt securities, which are subject to greater interest rate, credit and liquidity risks, higher volatility and greater risk of loss of principal and interest than higher-rated debt securities.

Chinese Consumer Sector Shows Improvement



Highlights:

- 1. Chinese government introduces more supportive policies to stimulate consumer spending
- 2. More exposure added in Chinese insurance stocks as premium growth picks up
- 3. Chinese high yield industrial bonds recover following a resumption of onshore bond issuance

Market Review and Outlook

Equities

- China's economic data in August was mixed. Industrial production and retail sales were in line with market expectation, while fixed-asset investment underperformed due to under-spending on infrastructure. There have been further indications that the property market is slowing down, with developers more conservative about acquiring land.
- Potential renegotiation on trade issues between China and the U.S. failed to take place, as the U.S. imposed additional tariffs on Chinese goods before the scheduled talks. Detecting signs of a looming macro downturn, China's government introduced more supportive policies, particularly related to consumer spending.
- In terms of sectors, industrial outperformed as market expected potential stimulus on infrastructure spending.



Bonds

- Chinese high yield industrial bonds recovered in September following a resumption of onshore bond issuance and positive corporate event on individual names.
- The People's Bank of China cut the reserve requirement ratio by 100 basis points in early October to smooth liquidity conditions and support corporate lending amid rising trade tensions.

Investment Strategy

<u>Equities</u>

- The Fund has an overweight in the energy and insurance sectors, which they are better shelters during a slowing economic environment. The Chinese insurance sector is seeing a pick-up in premium growth following the normalisation of product regulations in the fourth quarter.
- Investment value is starting to emerge from oversold consumer names in China; the related corporations are showing improvements in business operations.

Bonds

- The Fund maintains a defensive strategy, with security selection skewed toward more defensive short-dated bonds and issuers with better credit quality. We also looking to switch from some high yield positions into investment grade bonds.
- In terms of high yield bonds, we prefer short-dated Chinese property for their attractive valuations and solid fundamentals.
