

Fund Monthly Report

Important note:

- 1. BEA Union Investment China Gateway Fund (the "Fund") seeks medium to long term capital growth and income through investing primarily in equity securities and/or debt securities, that are either (a) traded in China or (b) issued by entities incorporated in China or entities which have significant operations in or assets in, or derive significant portion of revenue or profits from China.
- 2. The Fund's investments are concentrated in China's equity securities and debt securities. This may result in greater volatility than a fund having a more diverse portfolio of investments. The Fund may also be subject to withholding and other taxes imposed in China.
- 3. The Fund may invest in below investment grade, or rated BB+ or below by a China credit rating agency, or non-rated debt securities, which are subject to greater interest rate, credit and liquidity risks, higher volatility and greater risk of loss of principal and interest than higher-rated debt securities.

Consumer Staple Stocks Added Due to Tax Cut



Highlights:

- 1. Chinese government introduces stimulus measures amid economic downturn
- 2. Exposure added in consumer staple stocks due to household income tax cut in China
- 3. Reduced positions in Chinese high yield property and industrial bonds with weaker credit quality

Market Review and Outlook

Equities

- China's onshore and offshore equity markets underwent a significant correction in October, mainly due to increasing signs of an economic downturn and volatility in the global equity markets. At the same time, some A-share and Hshare companies slightly missed market expectation for their third quarter earnings.
- The central government has started launching more stimulus measures, including RRR cuts, increased export tax rebates, tax reductions on household income, and additional supportive measures for private enterprises.
- In Hong Kong's equity market, the telecommunications sector comparatively outperformed in October as competition eased and monthly tariffs for service packages increased.





Bonds

- Chinese high yield property names underperformed as National Bureau of Statistics data confirmed a weakening trend
 on the sector while individual bond issuance in an unexpectedly cheap value also triggered further re-pricing of the
 sector.
- Chinese high yield industrial bonds was impacted by a weaker A-share equity market and idiosyncratic headline risk of certain names.

Investment Strategy

Equities

- We have added consumer staple stocks, which are less impacted by the economic slowdown and are set to benefit from the rising purchasing power of citizens as a result of income tax cuts.
- The Fund has maintained its overweight position in the insurance sector, seeing a pick-up in premium growth following the normalisation of product regulations in the fourth quarter.
- The Fund has gradually built up its position in the Chinese healthcare sector, and we expect the leading pharma manufacturers to benefit from faster drug approval process and to gain market share from smaller players.

Bonds

- The Fund maintains a defensive strategy, with security selection skewed toward more defensive short-dated bonds and issuers with better credit quality. We will keep to a higher allocation in investment grade bonds in the near term.
- In terms of high yield bonds, we have reduced our positions in Chinese high yield property and industrial bonds with weaker credit quality.
