

Important note:

1. BEA Union Investment China Gateway Fund (the “Fund”) seeks medium to long term capital growth and income through investing primarily in equity securities and/or debt securities, that are either (a) traded in China or (b) issued by entities incorporated in China or entities which have significant operations in or assets in, or derive significant portion of revenue or profits from China.
2. The Fund’s investments are concentrated in China’s equity securities and debt securities. This may result in greater volatility than a fund having a more diverse portfolio of investments. The Fund may also be subject to withholding and other taxes imposed in China.

Hong Kong Property Stocks Outperform

*Highlights:*

1. **Chinese government continues stimulus measures for enterprises**

Market Review and OutlookEquities

- China’s onshore and offshore equity markets experienced a strong rally in November, with trade war concerns receding after a meeting between presidents Trump and Xi at the G20 summit was confirmed.
- The central government is continuing to provide support for small and medium-sized enterprises as well as private companies by instituting further financial measures, including government-led investment fund, equity and bond financing and bank loan allocation.
- Hong Kong equities gained sharply in November, with the property sector outperforming due to an expectation of slower rate hikes in the U.S. following a more dovish tone from the Federal Reserve. Retail sector remained sluggish with concerns of renminbi weakening.

Bonds

- Chinese high yield property outperformed as yields for B-rated names dipped slightly. Chinese high yield industrial bond yields further increased due to headline news and concerns about refinancing.
- We remain cautious on the Chinese high yield bond market due to trade war concerns, volatility in emerging market currencies, and tight onshore funding for trusts and privately-owned companies.

Investment Strategy

Equities

- We now have a more positive view towards the consumer discretionary sector, as we see investment value in some oversold consumer names after the huge sell-off.
- We have an overweight in the consumer staples sector, which is less impacted by the macro economy and is expected to benefit from the upward trend of consumer prices in China.
- The Fund is selectively investing in Chinese industrial sector, which benefit from the government's expansionary fiscal policy.

Bonds

- The Fund maintains a defensive strategy, with security selection skewed toward more defensive short-dated bonds and issuers with better credit quality. We will keep to a higher allocation in investment grade bonds in the near term.
- We have reduced our positions in Chinese high yield property and industrial bonds with weaker credit quality, and switched into Indonesian quasi-sovereign bonds.
