

Fund Monthly Report

Important note:

- 1. BEA Union Investment China High Yield Income Fund (the "Fund") seeks to achieve medium to long term capital growth and regular income by primarily investing in high yield debt securities that are issued or guaranteed by entities which are incorporated in China or have significant operations in or assets in, or derive significant portion of revenue or profits from China.
- 2. The Fund may invest significantly in below investment grade or non-rated debt securities, including high yield bonds, which are generally subject to lower liquidity, higher volatility and greater risk of loss of principal and interest than higher rated securities.
- 3. The Fund's investments are concentrated in China. The value of the Fund may be more volatile than that of a fund having a more diverse portfolio of investments.
- 4. The manager may at its discretion make distributions from income and/or capital in respect of the distributing classes of the Fund. Chinese High-yield Industrial Bonds Remain Resilient



Highlights:

- 1. Chinese high yield industrial bonds with shorter duration remain resilient with rising yields

Market Review and Outlook

Review of Interest Rate Market

 As economic data continued to be stronger than the market expectation and with the new Federal Reserve chairman, Jerome Powell reaffirmed the monetary tightening stance, the 10-year U.S. Treasury yield gradually climbed toward 2.9%.

Chinese High Yield Bonds

- Chinese high yield bond market softened in the first half of February but saw some rebound during the second half of the month.
- Long-dated Chinese high yield property bonds saw the biggest correction due to rising yields, while Chinese high yield industrial bonds remained relatively resilient due to their shorter average duration.
- In light of rising financing costs for the Chinese onshore bond market, new supply in the offshore bond market is expected to increase. However, we are positive on Chinese high yield U.S. dollar bonds due to consistent demand from Chinese investors.





Investment Strategy

- The Fund remained strategically defensive in February. It continued to trim its exposure in long-dated bonds and higher beta names, while switching into more defensive short-dated bonds.
- The Fund continues to tactically participate in investment grade and high yield new issues with capital appreciation potentials.
