

Important note:

1. BEA Union Investment China High Yield Income Fund (the "Fund") seeks to achieve medium to long term capital growth and regular income by primarily investing in high yield debt securities that are issued or guaranteed by entities which are incorporated in China or have significant operations in or assets in, or derive significant portion of revenue or profits from China.
2. The Fund may invest significantly in below investment grade or non-rated debt securities, including high yield bonds, which are generally subject to lower liquidity, higher volatility and greater risk of loss of principal and interest than higher rated securities.

Market Review and Outlook

Review of Interest Rate Market

- U.S. Treasury yields held steady in January. The U.S. Federal Reserve (Fed) reiterated its willingness to be patient on further rate adjustment at a meeting of the Federal Open Market Committee in January 2019.

Chinese High Yield Bonds

- Chinese high yield property bonds rallied in January but to a slightly lesser extent, due to lower average duration and continuous new supply during the month.
- Chinese high yield industrial names saw similar total returns to that of the property sector, supported by a rebound in oil prices and revaluation of lower bond prices.
- The U.S.-China trade talks will likely continue to be an important factor affecting risk sentiment in general. We are seeing fairer high yield valuations overall following the recent rally.
- In terms of individual sectors, we expect to see higher risk in privately owned Chinese industrial names due to their relatively tight onshore funding.

Investment Strategy

- The Fund has been picking up bonds in the primary market, as we are seeing attractive new issue premiums in Chinese high yield segments.
- The Fund also added position in long-dated Chinese high yield property bonds.
- The Fund continues to look for opportunities to invest in higher yielding names with decent valuations and better credit quality.
