

# BEA Union Investment Asian Strategic Bond Fund

- BEA Union Investment Asian Strategic Bond Fund (the "Fund") invests in emerging markets and may be subject to higher liquidity and volatility risks.

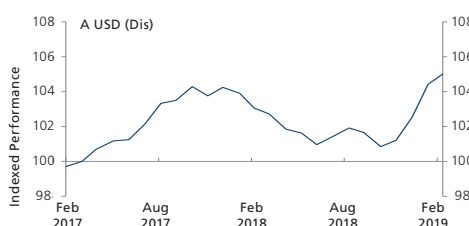
