Increase Allocation to Asian High Yield Non-property Bonds



Highlights:

1. The Fund increased allocation to Asian high yield non-property bonds for diversification purpose
2. The Fund turns defensive in view of the volatility caused by trade dispute
3. We are turning more cautious on Asian local currency bonds in the near term

Fund Features

- The Fund adopts unconstrained strategy, with maximum flexibility allowed in allocating assets among corporate bonds, government bonds, high yield bonds and investment grade bonds, actively hunting for alpha opportunities.
- Seeks stable dividends and exploits appreciation potential of Asian bonds.

Market Review and Outlook

Review of Interest Rate Market

- The market has priced in a lower possibility of rate cut by the end of 2019 following the Federal Open Market Committee (FOMC) meeting. The U.S. Treasury yields went up slightly due to the less than dovish tone from the Federal Reserve (Fed) and a series of solid economic data.
- In April, the 10-year U.S. Treasury yield traded in a tight range between 2.46% to 2.59% and remained range-bounded.

Asian High Yield Bonds

- In April, Asian high yield credit market remained stable overall. Chinese industrial, Indian corporates and Macau gaming sectors were top performing, where we see moderate spread tightening driven by the demand from diversification.

- Chinese high yield property bonds underperformed in April, the sector was impacted by the increase in new issues and tightening policy in certain cities. Indonesian high yield property bonds also underperformed, mainly due to risk-off sentiment ahead of the president election.

Asian Local Currency Bonds

- Asian local currency bond markets corrected mildly in April as a result of the rebound of the U.S. Treasury yields. Meanwhile, investors were getting more cautious before the national election in India and Indonesia.

Market Outlook

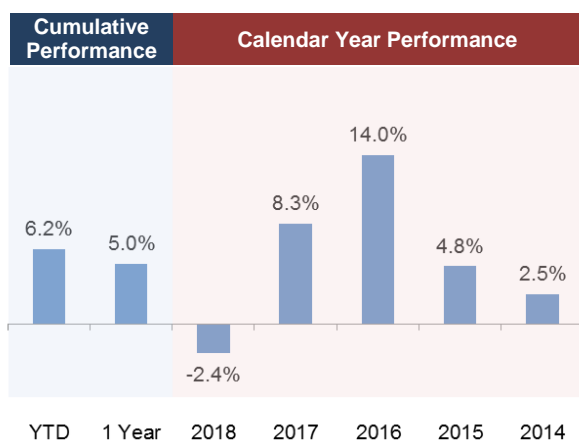
- We expect the recent tensions in trade dispute and mixed economic data will affect overall risk sentiment and add volatility to the market.
- As certain sectors were impacted by the increase in bond issuance following the reporting period, we expect investors will turn more conservative, solid names with moderate duration and higher yield pickup will likely to outperform.

Investment Strategy

- The Fund slightly reduced higher beta names and longer duration tranches in the Chinese property sector. At the same time, the Fund increased allocation to Asian high yield non-property sectors for diversification purpose.
- In view of the volatility caused by trade dispute, the Fund will turn defensive and trim names with higher beta, tight valuations and long duration due to the supply pressure, particularly on the Chinese property sector.
- We become more cautious on Asian local bond market in the near term as we see downward pressure on emerging market currencies due to the rebound of the U.S. dollar.
