Important note:

Constructive on China A-shares



Highlights:

- 1. Chinese onshore and offshore equity markets continued to rally strongly in February
- 2. Remain constructive on China A-shares due to strong fund flows
- 3. The Fund continues to overweight BBB rated bonds in China, India and Indonesia

Fund Features

- The Fund is an Asia Pacific equity-biased mixed-asset income fund, which invests in a prudent selection of blue-chip stocks with stable earnings and dividend growth potential.
- The Fund captures Asia Pacific blue chips' appreciation potential using a strategy of lower volatility, it employs flexible allocation in Asia Pacific bonds to enhance returns and diversify portfolio risks.

Market Review and Outlook

Equities

- China's onshore and offshore equity markets continued to rally strongly in February, mainly driven by the positive developments in the U.S.-China trade negotiations and favourable global liquidity environment.
- Australian equities remained firmed and outperform the region in February, mainly driven by financial, energy and material sectors. The financial sector experienced a relief rally on the release of the banking royal commission's final report, which was more benign than expected.
- Hong Kong equity market continued its upward trend in February. The property sector lagged due to its low beta nature, retail sector gained on strengthening renminbi and strong sales recorded in the Chinese New Year.

 Taiwan's equity market gained in February, technology sector outperformed due to more positive outlook of the U.S.-China trade negotiations. Several technology companies reported better than expected 2018 fourth quarter results and monthly sales figures.

Bonds

- In terms of Asian investment grade bonds, we expect the market will remain solid unless significant supply emerges. Given the low volatility seen in the U.S. Treasuries, Asia's credit spread will likely remain stable and range-bounded.
- In February, Chinese high yield property names outperformed the market driven by improving offshore funding environment, positive credit event of selective names and attractive valuation especially on the high beta and long tenor bonds.

Investment Strategy

Equities


- The Fund increased its weighting in equities via China on the back of improved sentiment, especially for the laggards with attractive valuations.
- The Fund added into higher beta stocks in IT, insurance and diversified financial sectors while trimmed defensive stocks such as utilities and banks.
- We remain constructive on Chinese equities particularly A-shares due to strong fund flows and higher global index inclusion.

<u>Bonds</u>

- In terms of Asian investment grade bonds, the portfolio's duration remains neutral. We are adding laggards with fair valuation selectively and continue to overweight BBB rated names in China, India and Indonesia.
- In terms of Asian high yield bonds, we continue to look for opportunities to pick up higher yielding names with decent valuations and better credit quality.
