Central Banks' Dovishness Remains Favourable to Asian Bonds

Highlights:

- 1. Dovish stance by the central banks will continue to support Asian local bond markets**

Fund Features

- The Fund focuses on high yielding Asia Pacific bonds and equities, distributions from both bonds and equities are the main source of income.

Market Review and Outlook
Bonds

- In July, overall market remained relatively flattish as investors were awaiting the meeting between the U.S. and China and also the U.S. Federal Reserve (Fed)'s rate cut decision.
- Chinese high yield property names remained largely stable despite headlines on policy tightening; Chinese high yield industrial names were hit by the weak sentiment in onshore bond market.
- In July, the credit spreads of Asian investment grade bonds tightened marginally. We expect the higher beta names will become more volatile following the escalation of trade war.
- We expect the U.S. Treasury yields will continue to stay at low level. The increasing willingness to implement easing policy by the central banks will continue to support Asian local bond markets.

Equities

- The MSCI Asia Pacific ex Japan Index retreated in July. The bullish sentiments in June abated due to a milder than expected Fed rate cut, the Japan-Korea trade dispute, uncertainties in the Union's budget proposal in India and rising political tension in Hong Kong.
- Taiwan was one of the best performing market in the region in July, led mainly by the technology sector as it was deemed to benefit from the Japan-Korea trade dispute and market sentiment was boosted by decent earning release in the U.S. and Taiwan.

Investment Strategy

Bonds

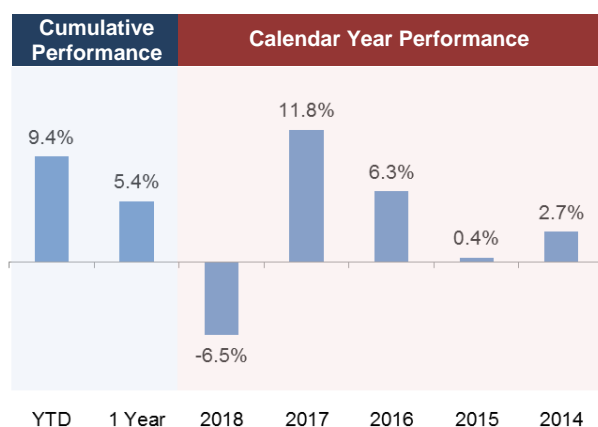
- In terms of investment grade bonds, the Fund continues to slightly overweight the portfolio's duration. We have trimmed some higher beta names and took profit from bonds issued by asset management companies, property names and some higher beta names in India.
- In terms of Asian high yield bonds, the Fund selectively lengthened its duration to capture the benefit of spread tightening. It has reduced higher beta names in India and Indonesia.

Equities

- The Fund continues to position into higher yielding names in Australia, Singapore and Hong Kong.
- We remain positive towards bond-proxy stocks, REITS, companies committed to dividends and dividend growers.
- We will opportunistically adding laggards with decent yields to enhance returns.
