

# **Fund Monthly Report**

#### Important note:

- 1. BEA Union Investment Asia Pacific Multi Income Fund (the "Fund") seeks to achieve income and long-term capital growth by investing in an actively managed portfolio of debt securities, listed REITs, and other listed securities in the Asia Pacific region.

# The Reopening of Economies Boosts Investor Sentiment

# **Market Review and Outlook**

#### **Bonds**

- The COVID-19 pandemic is further controlled in many countries except a few, governments announced the gradual lifting of lockdown and to reopen the economies. Asian high yield bond market saw strong inflows in May.
- India and Indonesia announced policy support amounted to 10% and 3.9% of the GDP respectively, Indian and Indonesian non-bank financial institution and commodity names outperformed as a result of policy support and recovery of commodity prices. Chinese high yield property names extend their gains, despite at a smaller magnitude.
- In terms of Asian investment grade bonds, market liquidity continued to improve in May and the higher beta names had started to catch up. We expect the market to remain solid and credit spreads mildly tighten on the back of the riskon sentiment.





### **Equities**

- Asian equities closed slightly down in May, while Malaysia, Australia and Thailand markets were the outperformers. In
  Australia, the performance was broad-based and supported by the stronger Australian dollar, which was partly driven
  by the rebound in iron ore price. Thailand equities also driven by Thai baht appreciation, its financial and healthcare
  sectors led the gain.
- The reopening of economies boosts investor sentiment. Market turnovers were strongly lifted by buying from the retail investors. We expect the market to remain volatile amidst geopolitical risks and trade negotiations. However, the central banks' easing and policy stimulus may provide near term support and investment opportunities.

## **Investment Strategy**

#### **Bonds**

- We are modestly optimistic towards Asian high yield bonds. The Fund has switched into laggards as well as the metal and mining sector to capture the recovery of commodity prices. At the same time, the Fund increased its exposures in emerging market sovereign and quasi-sovereign bonds to capture the increasing inflows to the region.
- In terms of investment grade bonds, we added into higher beta names and increased the exposure in Indonesia, while
  investment in India remained underweight.

## **Equities**

- The Fund reduced its cash level and increased allocation in equities, added mainly in the energy and material sectors in Australia.
- We continue to position into higher-yielding names in Australia, Singapore and Hong Kong. We remain cautious of external risks, which may affect the earnings outlook and sustainability of dividends of selected companies.
