### The Fund Increases Exposure in High Quality REITs

*Highlights:*

1. Funds flow into the Asian bond market to seek yield
2. Stronger-than-expected quarterly earnings supports IT sectors performance
3. The Fund increases exposure in high quality REITs

**Fund Features**

- The Fund focuses on high yielding Asia Pacific bonds and equities, distributions from both bonds and equities are the main source of income.

**Market Review and Outlook**Bonds

- China's economy has recovered to pre-COVID 19 level, especially in property sales, the trend continues to look positive. In the Chinese property sector, the long end of high beta names was in strong demand.
- Asian high yield bond market performed well in July. Funds flowed into Asian emerging markets for yields. The attractive yield level and thin market inventory supported the outperformance of the Indonesian name.
- In terms of Asian investment grade bonds, the overall market continued to hold up well. We expect Asian investment grade credit spread remains stable, but the recent strong rally may prompt some healthy corrections.

### Equities

- Asian equities continued to rally in July, led by Taiwan, India and China. IT sector was the outperformers in Taiwan, reflecting positive takeaways from the third quarter results of U.S. technology companies.
- In China, domestic A-shares in material, consumer and IT sectors outperformed due to the good macro data releases and accelerating capital market reform, supported by high liquidity and retail participation.
- We expect the market to remain volatile amidst geopolitical risks and trade negotiations. However, the central bank easing and policy stimulus may provide near term support and investment opportunities.

### Investment Strategy

#### Bonds

- We are cautiously optimistic towards the Asian high yield bond market on the back of the market liquidity and policy support from the governments, especially the positive development of the Chinese property sector and recovery of commodity prices.
- In terms of investment grade bonds, we slightly overweight duration, and increase the exposure in China, Hong Kong and Indonesia, while investment in India remains underweight.

#### Equities

- In July, the Fund deployed cash and added in high quality REITs for defensiveness and dividends.
- We continue to position into higher-yielding names in Australia, Singapore and Hong Kong. We remain cautious of external risks, which may affect the earnings outlook and sustainability of dividends of selected companies.
