

Important note:

1. Constructive Technical Backdrop for Asian Investment Grade Bonds



Highlights:

1. The technical backdrop for Asian investment grade bonds remains constructive
2. Asian high yield bonds spreads continue to tighten
3. The Fund continues to overweight selective BBB-rated names

Fund Features

- The Fund adopts flexible allocation in Asian investment grade / high yield bonds, diversifying into different Asian countries, sectors, and currencies.
- The Fund invests not more than 50% in Asian high yield bonds in general conditions.
- Mainly invests in corporate bonds which tend to be less sensitive to rate hike cycle.

Market Review and Outlook

Review of Interest Rate Market

- The U.S. Treasury yields plummeted following the FOMC meeting, which signaled the pause for a further rate hike. The dovish stance of the U.S. Federal Reserve (Fed) shift mainly occurred in the context of downside risk to growth and muted inflation.

Asian Investment Grade Bonds

- In terms of Asian investment grade bonds, the market remained mostly range bound in March. Market demand has softened slightly as valuations became fairer while technical backdrop remained constructive.
- The rally of Asian credit has been strong year-to-date, we expect supply to increase in April, thus limiting further upside potential.

Asian High Yield Bonds

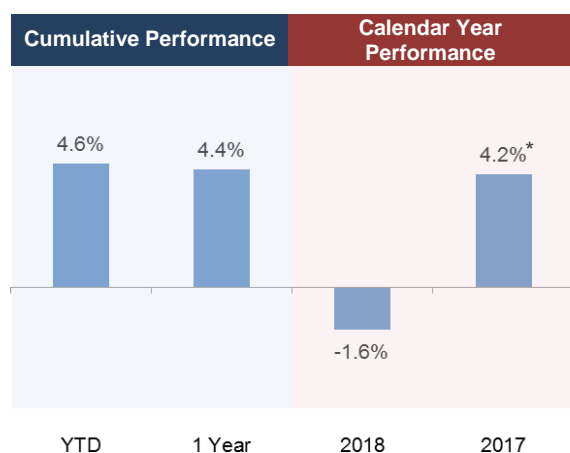
- In March, overall Asian high yield bonds spreads continued to tighten, supported by the risk on sentiment, limited supply and inflows. Chinese high yield property bonds were supported by muted new issuance due to reporting season. Corporate bond yields in Indonesia and India tightened as a result of higher oil price and laggard chasing.
- Chinese high yield industrial bonds underperformed in March due to weak full-year results announced by certain issuers and their tight valuations.

Investment Strategy

- In terms of Asian investment grade bonds, the Fund maintains its neutral position in duration. We will continue to overweight BBB-rated names selectively while underweight the technology sector.
- The Fund took partial profit from high yield bonds with tight valuations. At the same time, we will continue to look for opportunities to pick up some higher yield names with decent valuation and better credit quality.
- The Fund continues to maintain a small position in Indonesian local currency government bonds.
