

Fund Monthly Report

Important note:

- BEA Union Investment China High Yield Income Fund (the "Fund") seeks to achieve medium to long term capital growth and regular income by primarily investing in high yield debt securities that are issued or guaranteed by entities which are incorporated in China or have significant operations in or assets in, or derive significant portion of revenue or profits from China.
- 2. The Fund may invest significantly in below investment grade or non-rated debt securities, including high yield bonds, which are generally subject to lower liquidity, higher volatility and greater risk of loss of principal and interest than higher rated securities.

Market Review and Outlook

Review of Interest Rate Market

- The escalation of trade war and series of negative headlines pushed the U.S. Treasury yields to fresh year-to-date low. In May, the 10-year U.S. Treasury yield traded in a volatile range between 2.12% to 2.54% and has plummeted 38 basis points in one month.

Chinese High Yield Bonds

- In May, the overall high yield bond market weakened. Chinese high yield financial and Chinese high yield property sectors outperformed with a positive total return. The yield spread for Chinese high yield financial sector slightly tightened.
- Chinese high yield industrial bonds recorded a negative total return in May as the sector was dragged by few names with negative headlines.





- We expect the market will remain volatile due to the evolving progress of the U.S.-China trade talk, the weakening trend of the economic data in the U.S., as well as China's effort to calm down its active land market.
- We expect investors will turn more conservative, solid names with moderate duration and higher yield pickup will likely to outperform.

Investment Strategy

- The Fund reduced higher beta names and longer duration tranches in the high yield sectors. At the same time, it has been picking up U.S. Treasuries in light of risk off market sentiment.
- The Fund continues to remain defensive and maintain a moderately low level of high beta and long duration names in view of the uncertain macro economy, trade talk risk and tightening property policy in China.
