

Important note:

1. BEA Union Investment China High Yield Income Fund (the "Fund") seeks to achieve medium to long term capital growth and regular income by primarily investing in high yield debt securities that are issued or guaranteed by entities which are incorporated in China or have significant operations in or assets in, or derive significant portion of revenue or profits from China.

Review of Interest Rate Market

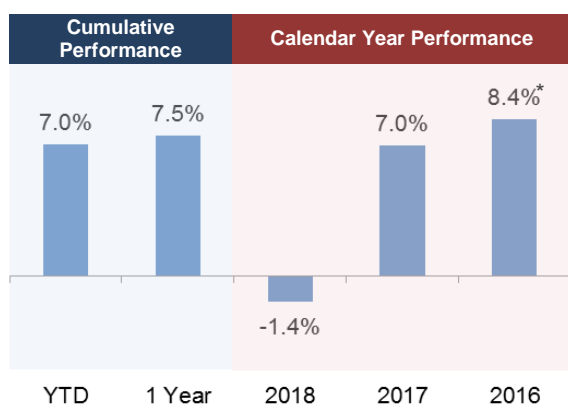
- The U.S. Treasury yields continue to drop amid uncertain global backdrop. In July, the 10-year U.S. Treasury yield traded in a volatile range between 1.95% and 2.15% and closed at 2.01%.

Chinese High Yield Bonds

- In July, overall market remained relatively flattish as investors were awaiting the meeting between the U.S. and China and also the U.S. Federal Reserve (Fed)'s rate cut decision.
- Chinese property names remained largely stable despite headlines on policy tightening; Chinese industrial names were hit by the weak sentiment in onshore bond market.
- In light of escalating trade war tensions between the U.S. and China, the weakening trend of economic data in these two biggest economies, along with the longer term liquidity impact from a troubled commercial bank, the market is expected to remain volatile as more headlines emerge.

Investment Strategy

- The Fund reduced higher beta names in the high yield segment and increased allocation to investment grade names.
- The Fund remains position modestly defensive and maintains a moderately low level of higher beta and longer duration names in view of the tightening liquidity situation, restrictions on the Chinese property market, increasing tensions in the trade talk.
- At the same time, the Fund continues to look for opportunities to pick up high yield names with attractive valuations.
