

**Fund Monthly Report** 

Important note:

- 1. BEA Union Investment China High Yield Income Fund (the "Fund") seeks to achieve medium to long term capital growth and regular income by primarily (i.e. at least 70% of its net asset value) investing in high yield debt securities that are issued or guaranteed by entities which are incorporated in China or have significant operations in or assets in, or derive significant portion of revenue or profits from China.
- 2. The Fund may invest significantly in below investment grade or non-rated debt securities, including high yield bonds, which are generally subject to lower liquidity, higher volatility and greater risk of loss of principal and interest than higher rated securities.
- 3. The Fund invests in debts or fixed income securities are exposed to interest rates, credit/counterparty, downgrading, volatility and liquidity, valuation and sovereign debt and credit rating risks which may adversely affect the price of the debt securities.

#### Market Review and Outlook

Review of Interest Rate Market

- In November, the U.S. Treasury yields were higher compared to the previous month due to trade talk optimism and continued expectation on rate cut pause. The 10-year U.S. Treasury yield traded in a volatile range between 1.7% and 1.94% and closed at 1.78% at the end of the month.

#### Chinese High Yield Bonds

- In November, overall market edged up as the U.S.-China trade talk remained fairly optimistic and hardly any negative surprise on the economic data in China and the U.S.
- In terms of sectors, Chinese property names outperformed due to their strong contract sales figures and relaxation of housing policies in certain cities. Chinese industrial names underperformed due to idiosyncratic risk on failed acquisition and change of auditors of two issuers.
- We expect the market will have a moderately higher risk appetite on beta and duration, valuation on lower beta names are getting rich.

#### **Investment Strategy**

- The Fund will position constructively and maintains a slightly higher level of higher beta and longer duration bonds in view of the strong Chinese property market and the positive progress on U.S.-China trade talk.

- At the same time, we continue to look for opportunities to pick up high yield bonds with attractive valuations.
