

# **Fund Special Report**

#### Important note:

- 1. BEA Union Investment China High Yield Income Fund (the "Fund") seeks to achieve medium to long term capital growth and regular income by primarily (i.e. at least 70% of its net asset value) investing in high yield debt securities that are issued or guaranteed by entities which are incorporated in China or have significant operations in or assets in, or derive significant portion of revenue or profits from China.

#### **Market Review and Outlook**

### Interest Rate Market

- In September, the U.S. Treasury yields were largely stable. The 10-year U.S. Treasury yield traded in a range between 0.63% and 0.72% and closed 2 bps lower for the month. We expected the U.S. Treasury yields will trade upwards on the back of inflation expectation and yield normalization.

#### Chinese High Yield Bonds

- Asian bond market performed weakly during the month with fabricated letter from a market leading Chinese property developer triggered property sector correction. With the strong response and counterattack to the short sellers, the Chinese property bond market has been largely stabilized towards month-end.
- The resurgence of COVID-19 cases in September aroused the worries of lock down reimposed, which casted concern on oil demand recovery. Along with China repeatedly reduced its oil import due to its high inventory, oil retreated during the month.
- Fed continued to support the low interest rate environment and most importantly resilient and strongly recovering China economy will continue to support future performance on China high yield bonds.





# **Investment Strategy**

- The Fund will be balanced in overall risk level while tactically add names with relatively large correction recently.
- The Fund will continue to adopt a more active switching and bond picking approach to capture solid laggards with bottoming out fundamentals and sectors supported by policy, while reducing names with high refinancing risk.
