U.S. Treasury Yields Continue to Stay at Low Level



Highlights:

- **1.** The U.S. Treasury yields is expected to stay at low level on the back of potential rate cuts
- 2. Our preference remains on higher quality global investment grade bonds
- 3. The Fund continues to invest into stocks with appealing growth and reasonable valuations

Market Review and Outlook

Bonds

- In terms of global investment grade bonds, credit spreads widened by 10 to 20 basis points in general due to risk-off sentiment in August. We expect credit spreads to tighten following a strong rally year-to-date and no further catalyst to support.
- In August, overall Asian high yield bond market weakened due to escalation of the U.S.-China trade war, weakening commodity prices and further tightening of housing policy in China. In terms of sectors, financials and Indian utilities outperformed the most with stable returns, while Indonesian metal and mining sector was the most underperformed.
- We expect the U.S. Treasury yields will continue to stay at low level as global central banks continue to ease monetary policy and cut interest rates.

Equities

- The world's equity markets retreated across the board in August, U.S. equities also pulled back but outperformed relatively. The uncertainties around the U.S.-China trade conflict continued to haunt the markets. In terms of sectors, cyclical, energy and banking were hit the most.
- European equities dropped along with global equities. Economic data continue its weakening trend, intra-European Union trade statistics fell further and German industrial production growth reported its lowest level since 2009. The market is expecting more interest rate cut by European Central Bank on the back of deteriorating economic activities.
- Japanese equities showed relatively resilient amid rising volatility in global markets. Japan's economic data is improving, in the second quarter, real GDP and industrial production surprised the market on the upside.

Investment Strategy

Bonds


- In terms of global investment grade bonds, the Fund's duration positions were slightly overweight. We maintain a strong preference for higher credit quality names of global investment grade bonds.
- The Fund will position modestly defensive in Asian high yield bonds and maintains a slightly lower level of higher beta and longer duration bonds in view of the tightening Chinese onshore liquidity, restrictions on the Chinese property market and evolving development of the trade talk.

Equities

- There was no major change to the Fund's portfolio in August.
- The Fund has a neutral stance on regional allocation and systematically invests in companies with appealing growth and reasonable valuations in their industries.
