

Important note:

- 1. BEA Union Investment RMB Core Bond Fund (the "Fund") seeks to achieve income and long-term capital growth by investing in debt securities and other assets that are denominated in RMB and other currencies.
2. The Fund invests in debts or fixed income securities are exposed to interest rates, credit/counterparty, downgrading, volatility and liquidity, valuation and sovereign debt, credit rating risks and credit rating agency risk (for mainland China onshore debt securities) risks which may adversely affect the price of the debt securities.

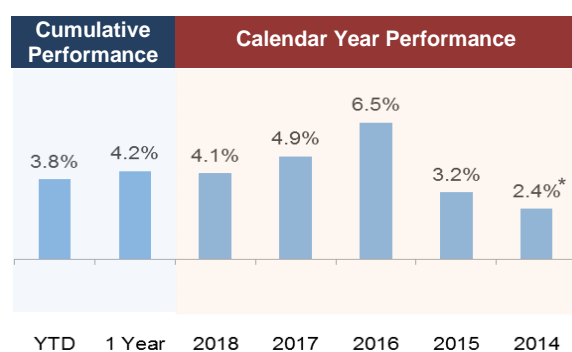
Market Review and Outlook

- In November, the renminbi strengthened against the U.S. dollar due to positive expectations on the U.S.-China trade talk.
- Onshore Chinese government bonds and policy banks bonds rebounded as the People's Bank of China injected more liquidity to the market and cut the loan prime rate and medium-term lending facility rate by 5 basis points. Chinese offshore renminbi bond market held resilient with limited new issue supply.

Investment Strategy

- The Fund switching from low yielding short-dated investment grade bonds and adding into longer-dated bonds to enhance carry.
- We continue to look for investment opportunities in investment grade offshore renminbi bonds.
- The Fund continues to invest into U.S. dollar denominated bonds through currency hedge.
